WISCONSIN TROUT UNLIMITED

"CONSERVATION ORGANIZATION of the YEAR."





At the 35th annual Awards Banquet of the Wisconsin Wildlife Federation on April 23rd in La Crosse, WI., Wisconsin Trout Unlimited was awarded the CONSERVATION ORGANIZATION OF THE YEAR award by the Federation for its long record of achievement in trout stream habitat improvement and conservation education. In the last 10-12 years, Wisconsin Trout Unlimited has expended well over 45,000 man-hours plus over \$25,000 on coldwater resource improvement projects in the state. State Council Chairman Tom Flesch of Poynette accepted the award on behalf of the Wisconsin State Council, saying "We appreciate receiving this award, because it means we have been recognized by our peers as being in the forefront of coldwater resource conservation in the state of Wisconsin. We thank the Wisconsin Wildlife Federation for this recognition and we pledge to continue our efforts to maintain and restore the trout fishery in our state."

(For those folks with good eyesight, the critter on top of the award is a BEAVER! The WWF says the beaver was not put there on purpose! We hope so! A member of the Wisconsin Trappers Association volunteered to make a miniature Conibear trap as part of the award plaque.)

Wisconsin Trout Unlimited is pleased to be so honored by the Wildlife Federation. The award speaks well for the quality and dedication of our organization. Wisconsin T.U. will continue to monitor, improve and restore the trout resources we have for now and in the future!

Wisconsin Stream Profile



The Namekagon River, one of the premier trout rivers in Wisconsin and the upper Midwest, originates from a lake in Bayfield County and travels 63 miles in a southwesterly direction before making a confluence with the St. Croix River. The trout water stretch of the Namekagon is considered to be the first third of the river.

When Europeans first came to the country in the late 1800's, brook trout were the dominant species in the Namekagon. Rainbows were stocked around 1910, and the stocking combined with forest clearing in the watershed diminished the brook trout populations. Brown trout were introduced in the 1930's and remain the dominant species today.

The Namekagon was one of the first rivers in the nation to be declared a "Wild and Scenic River" under legislation enacted in 1971. While that designation has been helpful in preventing further degradation of the river, it has also produced the result that stream improvement projects are not allowed to be undertaken on the Namekagon. A few structures placed in the river before the designation of the river as Wild and Scenic are still in place today and are benefitting the river yet.

In order to come up with a method of "improving" the Namekagon, DNR fish manager Frank Pratt of Hayward has worked to implement a policy now in place known as "slot sizing" regulations. Pratt determined that a portion

of the Namekagon called the "Seeley" stretch had harvest rates of larger fish (10" to 15") that were unacceptable for the maintenance of good populations. Fair to good natural reproduction occurs in this part, but angler harvest was preventing too many trout in the 10" - 15" range from living to spawn in fall. He thus proposed that a 6.6 mile part of the Namekagon in Sawyer County near Seeley receive the slot sizing regulations for trout fishing, whereby all trout between 10.0" and 14.9" must be released, and artificial lures only are permitted. Pratt has also encouraged anglers to keep more fish (within creel limits, naturally!) between 6" and 10", because he feels that releasing trout under 10" is "misdirected catchand-release", since a large proportion of trout in this size category perish from natural causes, anyway.

The regulations went into effect this season (1983) and WILD RIVER TU Chapter president Joel Johnson reports that he has seen some positive aspects already. Angler pressure has been decreased quite a bit on the special regs stretch, and Joel reports seeing more fish in the 10" to 15" range. It is too early to say, however, that this regulation has produced positive results; more data compilation will be needed on the project.

The Namekagon receives the bulk of its pressure from anglers outside a 50-mile radius of the river; these anglers come mainly from Eau Claire and Hudson, but also from as far away as Madison, Milwaukee, and Green Bay. There are numerous places to fish the Namekagon. Highway 63 between Cable (Bayfield Co.) and Hayward roughly parallels the river and provides several access points. The County "M" crossing east of Cable is another favorite spot. The Namekagon gets good hatches of the big Hexagenia limbata mayfly in late June and early July, along with other typical hatches throughout the year. Bait anglers do well in the early season, especially in the bigger water below Hayward. The usual array of spinning lures also provides good action. Campgrounds are plentiful in the area, plus there are many choices for hotel and motel accomodations in Hayward, Seeley, and Cable.

CHAPTER ACTIVITIES (cont'd)

Fox Valley: The Fox Valley Chapter has now completed two work days on the Davis Creek restoration project.

An annual outing with the handicapped was held on May 21 and was another enjoyable day. The weather cooperated and so did the trout.

The Fox Valley Chapter has been trying to extend Trout Unlimited exposure by placing a rotating slide show of streams, projects, and chapter activities in local businesses. This provides an intresting display for customers of the business and generates goodwill towards Trout Unlimited at the same time.

Fontinalis: The Fontinalis Chapter recently held a "tackle swap" on June 12th at their monthly meeting. Roughly \$100 was made for the chapter's future projects or donations.

In August the chapter will be doing a livestock fencing project on Pine Creek in cooperation with the Hay River Watershed Project in Barron County.

Central: In April, the Central Wisconsin Chapter completed the removal of several old beaver dams on the upper Mecan River. Within hours of removal, the orginal gravel bottom in some prime spawning areas was again exposed.

Also in April, a one day fishing clinic was held at Wautoma High School that was attended by 74 people. Instruction was given in casting, reading the water, insect identification, fly tying, knot tying, along with a showing of "The Way of the Trout". The event was well received and resulted in several new members.

The chapter's 7th annual Trout Fishing School was held June 3-5 at Camp Hiwela near Wild Rose in Waushara County. Both classroom and on the stream instruction provided a quality experience for both beginners and those hoping to polish existing skills. Although attendance was down this year, it allowed for more one-on-one instruction, to the benefit of the students.

Southern: On August 6, the chapter will be holding a Beer and Brat Festival. This will be the first year for this event and it is hoped that it will raise additional funds outside of the traditional banquet months. Southern Wisconsin has also just completed constructing three miles of fencing to keep livestock out of Deer Run Cr.

Chequamegon: On May 18, members of chapter testified at a hearing in opposition to an application to build a dam on Four Mile Creek in Bayfield County Wisconsin. Four Mile Creek is a tributary to the Sioux River watershed and has native populations of brooks, brown and rainbow trout. The creek also has anadromous trout and salmon runs from Lake Superior. A desision from the hearing is still pending.

Wisconsin Valley: This newly formed chapter has wasted no time working on fund raising and habitat. At the end of April the chapter held its first banquet with 239 attending. Just recently the chapter helped complete a DNR project by laying sod over bank structures on the Prairie River.

Ojibleau: The chapter has been working with the Chippewa County Highway Department to and has reached an agreement concerning ripraping in the Lowes Creek watershed. A 5-10 year monitoring program was also agreed upon.

The chapter has also been working on it's Operation Restore Project on Elk Creek and has been considering the purchase of 1.5 acres of land adjacent to the stream.

Kiap-TU-Wish: The chapter has been notified of the approval of its request for a 1983 Operation Restore grant for the Willow/Race Project. These grants were made for approved projects under National's Living Bright Waters program. Funds for the program were provided by the Richard Mellon Foundation.







Sportsmen's Lobbyist



Pictured above is former state senator Tom Harnisch, who now serves as a part-time lobbyist for the sportsmen of Wisconsin. Retained by the Wisconsin Wildlife Federation, Harnisch has been working on such matters as license fee increases, non-point pollution control, funding for beaver dam control and removal, the ban on phosphates in detergents, plus many other issues related to the hunters and anglers and trappers of Wisconsin. TU members Mitch Bent and Jim Lukens meet with Harnisch and other representatives from outdoor organizations each month to discuss the progress, or lack thereof, on various bills relating to the interests of the groups. For the reminder of those who may have forgotten, Harnisch was the author of legislation in 1977 that created the Inland Trout Stamp, revenues from the sales of which fund most of the stream habitat improvement projects in the state.

Legislative Update

LICENSE FEES INCREASED: the budget bill passed by the Legislature and signed by the governor calls for increases in hunting, fishing, and trapping licenses, plus an increase in the Inland Trout Stamp from \$2.50 to \$3.25. Overall increases were, on the average, about 20%.

BEAVER CONTROL FUNDS: thanks to efforts by Wisconsin TU'ers, the \$112,000/year funding for beaver control in the DNR budget is in the budget bill signed by the governor. Attempts were made to reduce the funding to \$30,000/year, but efforts by Reps. Sharon Metz (Green Bay) and Jim Holperin (Eagle River), plus calls and letters by alerted TU'ers, helped keep the funding at \$112,000/year. The funds will be used to remove old dams and contract with trappers to trap beaver in problem areas.

PHOSPHATE BAN GAINS: the Assembly passed AB 138, a bill to restrict the amounts of phosphates in detergents sold in Wisconsin, by a 67-28 margin. The Senate Environmental and Energy Resources Committee passed the bill by 4-1, and the bill is awaiting action by the full Senate. TU'ers are urged to write their state Senators to support the bill; the Senate version is listed as SB 98. Refer to the bill number when you contact your senator.

WISCONSIN CONSERVATION CORPS: the plan to put young people to work on conservation projects, the WISCONSIN CONSERVATION CORPS, has been making progress. At this writing, it is not known if the bill was included in the budget bill or is going through the Legislature on its own. We hope to have information in the next QUARTERLY REPORT. Look for it then!

FOREST LAND SALE BEING STYMIED: plans by the Reagan Administration to sell off "excess" National Forest Land has been losing steam. Senator Robert Kasten and Rep. Les Aspin (both of Wisconsin) have led the fight to prevent the sale.

The second new Wisconsin T.U. chapter was formally organized on May 2, 1983, in Peshtigo, WI. The MARINETTE COUNTY CHAPTER of Trout Unlimited will work on trout resources in the Marinette County area.

The first meeting of the new chapter took place in early April, when Mitch Bent and Tom Mertens (National Director, Green Bay) presented a program on Trout Unlimited to interested trout anglers at Chrisel's Hall in Peshtigo. The attendees felt there was sufficient interest in the area to begin a chapter, so the first public meeting was set for May 2. At that meeting, Bent and Mertens again presented a program on T.U. and what it does to improve the coldwater resource. After a question-and-answer period, the audience viewed two films ("Trout Unlimited: If We Don't, Who Will?", and "The Way of a Trout").

The third new Wisconsin T.U. chapter initiated this year, the LAKESHORE T.U. CHAPTER, began on May 9th at the Club Bil-Mar in Manitowoc. Chapter organizer Bob Nenahlo of Denmark, WI., along with several other interested anglers, met through the winter months to discuss the chances of getting a T.U. chapter started for their area. Once interest was generated, Bob set up the meeting and the new chapter was on its way. Mitch Bent and Tom Mertens helped the new chapter get going by

giving their presentation to the large crowd that attended. John Nelson, DNR fish manager from Plymouth, WI., also attended, and explained to the group the various projects the chapter could help work on, including one on LaBudde Creek in Sheboygan County.

GREEN BAY: the Green Bay Chapter held its 8th annual banquet on April 8th, 1983, at Cliff & Ceil's Hall in Green Bay. Over 720 people showed up to win a variety of door, raffle, and auction items. The \$10,923 netted from the banquet was a personal high for Green Bay TU, and it was the second most profitable TU banquet nationally (Denver TU raised \$15,000). Darrell Huff received the Member of the Year Award for his outstanding participation in stream improvement projects, and Paul Mineau received the Silver Trout Award for his long dedication to watershed improvement.

The chapter donated \$3,000 and \$1,000 to National TU and Wisconsin TU, respectively, for funding their various projects and expenses.

Chapter members have spent 4 Saturdays and over 250 hours installing wing-dams and undercut bank cover on the First South Branch of the Oconto River. Work is also slated on the LaMontagne Creek in Florence County.
